## Mr. Sumiyabazar Dolgorsuren

## Mayor of Ulaanbaatar and Governor of the Capital City



Mr. Sumiyabazar D. was appointed as Mayor of Ulaanbaatar and Governor of the Capital City of Mongolia in October 2020.

Mr. Sumiyabazar D. has many years of experience both in the public and private sectors. He served as the Chairman of the Board of the National Investment Bank from 2006 to 2013. Prior to that, he worked as the General Director of the "ABC Development" LLC from 2003 to 2006.

He was elected as a Member of the State Great Hural (Parliament) of Mongolia between 2012 and 2020. While serving as Member of Parliament, he also served as the Member of Cabinet and Minister of Mining and Heavy Industry from 2017 to 2020. Before being elected as Member of Parliament, he was the Representative of the Ulaanbaatar City Council from 2008 to 2012.

His other elected jobs include the Secretary of the Capital City Committee of the Mongolian People's Party from 2013 to 2017 and its incumbent Chairman since 2018.

He obtained his bachelor degree in Business Administration from the School of Computer Engineering and Management, University of Science and Technology in 2005.

Mr. Sumiyabazar D. was awarded the Order of "Red Banner of Labor" by the Government of Mongolia in 2014.



# **Mr. Jeong Hyup Seo**Acting Mayor of Seoul



Mr. Jeong Hyup Seo was appointed as Acting Mayor of the Seoul Metropolitan Government in July 2020. Prior to this current post, he served as first Vice Mayor for Administrative Affairs from January 2020.

Earlier in his career, Mr. Jeong Hyup Seo joined the government after passing the National Examination for Higher Civil Services in 1991. Some of the major posts he held include the posts of Chief Secretary of Secretary's Office, Director-General of Public Communications Bureaus, Deputy Mayor of Culture Headquarters

and Deputy Mayor of Planning and Coordination Office in succession.

Acting Mayor Mr. Jeong Hyup Seo holds a Bachelor of Arts in Economics from Seoul National University in Republic of Korea and obtained a Master of Science in Public Administration both from Seoul National University and Harvard Kennedy School, Massachusetts, United States.



#### **Doctor Takeshi Kasai**

## WHO Regional Director for the Western Pacific



Doctor Takeshi Kasai began his term as WHO Regional Director for the Western Pacific on 1 February 2019, following his nomination by the WHO Regional Committee for the Western Pacific and his appointment by the WHO Executive Board.

The public health career of Doctor Kasai began nearly 30 years ago when he was assigned to a remote post on the northeast coast of Japan, providing health-care services for the elderly. His early experiences there impressed upon him value of building strong health systems from the ground up. In the mid-1990s, Doctor

Kasai attended the London School of Hygiene & Tropical Medicine, where he studied in the Department of Global Health and Development and received a master's degree in public health.

Doctor Kasai has worked for WHO for more than 15 years, and at the time of his nomination was Director of Programme Management, the No.2 position at the WHO Regional Office for the Western Pacific in Manila, Philippines. As a Technical Officer and later as the Director of the Division of Health Security at the Regional Office, he was instrumental in developing and implementing the Asia Pacific Strategy for Emerging Diseases and Public Health Emergencies, which guides Member States in preparing for and responding to public health emergencies.

Doctor Kasai also served as the WHO Representative in Vietnam from 2012 to 2014, and in 2014 received the For the People's Health Medal from the Government, the top honor bestowed upon those who have made significant contributions to public health.

Doctor Kasai is from Japan. He is married and has three daughters.

## Consultant of the Organizing Committee of NEAMF



A former diplomat, Ambassador Badral Suren served as Ambassador-at-Large at the Mongolian Foreign Ministry and as Mongolia's Deputy Permanent Representative to the UN Offices at Bangkok and Geneva. Ambassador Badral worked as Chairman of the WTO Committee on Trade-related Investment Measures and Acting President of the Conference on Disarmament.

He was the Founding Interim Director of the International Think Tank for Landlocked Developing Countries and a member of the Foreign Ministry's Task Force for the Mongolia-China-Russia

Economic Corridor. He served as Foreign Policy Adviser to Prime Ministers and advised Foreign Ministers.

Ambassador Badral earned his MA degreed from the University of Hawaii at Honolulu and the Moscow State Institute of International Relations.

# Northeast Asian Mayors' Forum's Draft Charter (Summary)

At the 3rd Northeast Asian Mayors' Forum that took place in Ulaanbaatar 18-19 June 2018, the participating cities in their Outcome Document fully supported "the proposal of Ulaanbaatar to transform the Forum into a permanent mechanism and to establish Forum's secretariat in Ulaanbaatar".

They also agreed "to start developing a charter of the Northeast Asian Mayors' Forum and rules of procedure for the secretariat under the leadership of Ulaanbaatar. These founding documents must be submitted for adoption at the forthcoming 4th Forum".

Despite some delay due to the uncertainty on whether we will hold the 4th Forum or not in 2020 that was caused by the COVID-19 pandemic, the Ulaanbaatar City Government with the assistance of the Asia Foundation developed a draft Charter. The initial draft is subject to a thorough examination and discussion by the interested cities, and that process is being kicked off at the 4th Forum on 8 December 2020 and expected to continue well into 2021.

# Head of United Nations Economic and Social Commission for Asia and the Pacific (UN ESCAP) East and North-East Asia Office



Prior to joining ESCAP in 2019, Dr. Ganbold worked extensively for the government of Mongolia as a career diplomat, serving as Ambassador to the Republic of Korea (2013-2018) and Vietnam (2004-2008), and more recently as the Ambassador-at-large at the Ministry of Foreign Affairs for Sustainable Development. Earlier he served as the State Secretary of the Ministry of Foreign Affairs, the Director-General of the Departments of Public Affairs and Asia and the Pacific respectively, and in the Embassy of Mongolia in Pyongyang, DPR of Korea.

He earned his BA in International Relations from Moscow State Institute of International Relations (MGIMO), Russia, MA in Political Science from University of Hawaii at Manoa, USA, and PhD in Law from Hankuk University of Foreign Studies, Republic of Korea.

# Operationalizing NEAMF for shared prosperity

# (Summary)

Congratulating the NEAMF on taking the important step of the adoption of its charter, Mr. Ganbold Baasanjav, Head of UNESCAP East and North-East Asia Office, noted the NEAMF is a new addition to the city-based mechanisms in the subregion and suggested the Forum could benefit from the rich experiences of and partnership with the existing mechanisms and relevant organizations.

He also suggested the NEAMF connect the priorities of participating cities with regional and global agendas, including the 2030 Agenda for Sustainable Development, and help member cities devise local long-term plans as the backbone of the "low emission development strategies" and the enhanced nationally determined commitments by national governments under the Paris Agreement. He offered concrete opportunities for potential cooperation and partnership between the NEAMF and UNESCAP, based on its platforms addressing air pollution, low carbon cities and sustainable urban development.



# Mrs. Bayarchimeg Nanzad Deputy Governor for Human Development and Social Policy



Mrs. Bayarchimeg was appointed as the Deputy Governor for Human Development and Social Policy of the Ulaanbaatar city in November 2020.

Mrs. Bayarchimeg started her career in 2002 as Manager in charge of Legal Regulation at the Mongolia Representative Office of the Canadian Law Firm Rosenblatt and Associates. From 2003 to 2006, she worked as Specialist and Branch Head at the Mobicom Corporation. She then served as Specialist

for concession and public and private sector partnership and Head of the Integrated Investment Policy Department at the National Development Agency, the Government Regulatory Agency, between 2016 and 2017. Later, she served as the Head of the Legal Department of the Ministry of Mining and Heavy Industry. Between 2018 and 2020, she worked as the Vice-director of the Legal Department of the Erdenes Tavan Tolgoi JSC. Prior to her current appointment, she served as the Deputy Governor of the Songinokhairkhan District of Ulaanbaatar City.

She obtained her bachelor and master degrees in law from the National University of Mongolia and a master degree in International Business Administration from the Pacific States University in California, U.S.A.

# Policy Actions and Emergency Responses to the Covid-19 Pandemic - Case of Ulaanbaatar

## (Summary)

Mongolia was the only country that has prevented local transmission case of COVID-19 until the middle of November 2020. There were confirmed only imported cases, which was a result of the repatriation of the Mongolian citizens from abroad. Due to the first local confirmed case of COVID-19, Ulaanbaatar city and some provinces have moved to the state of Public Readiness Level on 13 November of this year and the public lockdown was partially extended until December 11, 2020.

The strategies such as tracking close and indirect contacts of confirmed cases, rapid and PCR testing are in place to prevent and reduce the spread of public transmission of infection.

Measures similar to social distancing, isolation, quarantine, lockdown and curfew are effective procedures during the airborne transmission of coronavirus infection.



#### PhD. Alexander POLYAKOV

# Director of Research and Development Institute for Urban Transportation SBI "MosTransProekt".



Mr. Alexander Polyakov worked in the structures of Russian Railways, in the IT Department of the Government of Moscow, in Moscow Traffic Control Centre as Deputy Head of Transport Planning and Information and Analytical Procurement.

Under the leadership of Mr. Polyakov a number of significant projects for the Moscow city have been developed and implemented including development and implementation of the Transportation Management Plan in Moscow during the 2017 FIFA Confederations Cup and 2018 FIFA World Cup, development

of Integrated Traffic Management Scheme (ITMS), creation of a Dynamic Transport Model of street and road network of Moscow, development and optimization of route network as well as LRT design.

Currently, Mr. Alexander Polyakov also serves as the Chairman of the Eurasian UITP Division and UITP vice-president.

# The operation of Moscow Transport during and after the pandemic (Summary)

Despite the lockdown, the operation schedule of all types of transport was fully preserved, this decision allowed the city to continue its life. The city was able to quickly organize a system of automated control over admission control. A platform to get a pass was created, where you could also check the pass online. We had regular disinfection in infrastructure and transport even before the pandemic. Now we carry out cleaning about 2, or even 15 times more often, and we will leave the new regulations even when the pandemic is over. Mandatory use of masks and gloves, regular informing on safety rules, sanitizers at stations, contactless payment - all this will remain in Moscow for a long time. We have placed tens of thousands of thematic posters and stickers on travel rules and safety measures on the metro and ground transportation infrastructure. For workers in the office and at transport facilities there are regular testings, temperature measurements and disinfection. Employees must use PPE.

During peak hours, about 100-120 thousand trips were made to the Moscow metro against 1 million at the beginning of March. The number of cars on the roads of Moscow during the period of self-isolation (April-May) compared with March, decreased from 20 to 50%. During the period of self-isolation, traffic jams did not exceed 1-2 points, even during peak hours. Today, the intervals of movement of metro trains are monitored in real time, they are displayed on a special display, and in the applications "Moscow Transport" and "Moscow Metro" you can select a less loaded carriage or ground transport. We have not reduced the operation for any type of transport due to the coronavirus - including to save jobs for workers in factories.



## Mr. Peng Yang

# Director of Administrative Office of the Global Health Center at Beijing Center for Disease Prevention and Control



Peng Yang serves as Director of Administrative Office of the Global Health Center at Beijing Center for Disease Prevention and Control, and the members of the Committee of Influenza Prevention and Control of China Preventive Medicine Association, Technical Working Group on Influenza of National Immunization Program, Vaccine Advisory Committee of National Medical Products Administration.

He is engaged in prevention and control of respiratory infectious diseases and emerging infectious diseases. He studied in the

University of New South Wales, US CDC and University of Oxford as a visiting scholar.

In 2014, he went to Guinea for fighting Ebola as the expert of public health. His researches of interests focus on epidemiological studies of COVID-19, seasonal influenza and avian influenza, including fields of early-warning, epidemiological and microbiological characteristics, risk factors and interventions. In recent years, he has published over 30 SCI-cited papers as the first author or the corresponding author and gained many professional awards.

In 2020, he was honored as National Advanced Individual in combatting COVID-19.

# Prevention and Control Measures of Covid - 19 in Beijing (Summary)

The strategy of guarding against imported infections and preventing a resurgence of local outbreaks is being put in place in China at present. A series of measures had been implemented in Beijing, China since COVID-19 outbreak early 2020, including preventing imported infections, social distancing measures tailored to levels of emergency response, community management, management of infections and close contacts, routine surveillance, assessment and stratification of risk levels, preparation and stockpile of adequate resources, guidance for the public, etc.

These measures are the cornerstone for effective suppression and containment of COVID-19 in Beijing to date.



# Mr. Lee, Sang Hoon

# Director-General of the International Cooperation Bureau Seoul Metropolitan Government



Mr. Lee, Sang Hoon was appointed as Director-General of Financial Affairs Bureau in January 2020 and concurrently has been serving as Director-General of the International Cooperation Bureau since August 2020.

Mr. Lee, Sang Hoon started his career in public service after passing the National Examination for Higher Civil Services in 1998. Some of the major posts he held include those of Director of Public Bus Policy Division, Director of Transportation Policy

Division and Director of Environment Policy Division in succession.

Director-General Mr. Lee, Sang Hoon holds a Bachelor of Arts in Political Science and Diplomacy from Korea University in Republic of Korea and obtained a Master of Science in Public Administration from Syracuse University in the United States.

# Seoul's Fight against COVID - 19 (Summary)

Since the occurrence of the first confirmed case of COVID-19 in Seoul last January, the Seoul Metropolitan Government has been focusing administrative efforts on containing the spread of COVID-19 based on 3 principles - speed, innovation, and transparency.

The aim of this presentation is to share Seoul's countermeasures regarding COVID-19 and to emphasize the need to move beyond national borders and engage in international cooperation.



#### Dr. Tamano Matsui

Programme Area Manager, Health Emergency Information and Risk Assessment, Health Emergencies Programme of the World Health Organization in the Regional Office for the Western Pacific



Dr. Tamano Matsui is a medical doctor and experienced epidemiologist. She received her medical degree from the School of Medicine in Kumamoto University, Kumamoto, Japan. She earned her PhD from the Faculty of Medicine, Graduate School of Medicine also from Kumamoto University. She has completed her Field Epidemiology Training Program (FETP) from the National Institute of Infectious Diseases (NIID) in Tokyo.

Dr. Matsui is currently the Programme Area Manager, Health Emergency Information and Risk Assessment, Health Emergencies

Programme of the World Health Organization in the Regional Office for the Western Pacific. Dr. Matsui has served as the Incident Manager of the COVID-19 Incident Management Support Team from September to November 2020.

Prior to this assignment, Dr. Matsui was Chief in the Office of Intelligence and Policy Planning, Infectious Disease Surveillance Center, NIID in Tokyo for seven years and had been involved in COVID-19 response since the emergence of the disease in 2020.

Dr. Matsui held the position of Medical Officer (FETP Coordinator) in the Emerging Disease Surveillance and Response, Division of Health Security and Emergencies in the World Health Organization in the Regional Office for the Western Pacific from January 2010 to March 2013. In her earlier years, Dr. Matsui was the Senior Research Scientist in the Intelligence and Policies, IDSC, NIID, in Tokyo, Japan. And a former Director of Dermatology of Amakusa Chuo General Hospital in Kumamoto, Japan.

and Chairman of the Citizens Representatives Khural of Songinokhairkhan District and the Advisor for the State Great Khural (Parliament) of Mongolia. Since 2016, he has served as the Governor of Songinokhairkhan District.

Mr. Sandagsuren J. obtained his bachelor degree in Mathematical modeling and Economist from the National University of Commerce and Business and master degree in Business Administration from the University of Finance and Economics of Mongolia.
